**BREEDING -**

**STALLION:**

- (1) The Lessee is authorized and required to file and sign all stallion reports.
- (2) The Lessee is authorized to sign all applications for registration of foals and breeding reports of mares, bred during the lease period.
- (3) The Lessee is authorized to sign as described in #2, but applications must be countersigned by the Lessor.

**MARE: (Regarding foal registration)**

- (4) The Lessee is listed as the breeder and owner of any foal, bred and produced during the lease period.
- (5) The Lessee is listed as the breeder only of any foal, conceived during the lease period.
- (6) The Lessee is listed as the owner only of any foal produced, during the lease period.

**GENERAL:**

- (7) The Lessee is authorized to collect, freeze, sell, and ship semen or eggs/embryos from this horse, during the period of this lease. Upon termination of the lease, any and all frozen semen or eggs/embryos becomes property of property of the: **(choose one)**       Lessor OR  Lessee

**SHOWING -**

- The lease of the above Stallion, Mare or Gelding is for the purpose of riding, showing, driving, etc., and no rights of breeding or foal ownership applies. However, the Sendera Draft Horse Registry will consider and recognize the Lessee as owner, only for the purpose of showing and publication of any show results, during this period.

The Sendera Draft Horse Registry is authorized to accept the signature of the Lessee on all showing reports, and breeding reports and/or applications for registration of foals in all cases above; in the case of #3 all documents must also have the Lessor signature.
