## INSTRUCTIONS

1. Keep a separate record sheet on each stallion used for breeding purposes, attach additional pages as needed.
2. This report should be postmarked by November 30th following the breeding year; any stallion reports received before January 31st are **free** to file. All reports received after January 31st, may incur a late fee.
3. The report must be filed in the office of the Sendera Draft Horse Registry no later than January 31st of each calendar year, for the preceding breeding year. Forms may be submitted via mail or an email attachment.
  - a. On or before January 31st of each year, the owner or lessee of every registered Sendera stallion must make a written report showing the names and registration numbers of all Registered or Approved Cross mares bred or exposed to the named stallion since the previous January.
    - i. The fee of **\$10** may be required on Stallion Breeding Reports received by the Sendera Draft Horse Registry with a postmark or an email date after January 31st following the breeding year.
  - b. The report must include all breeding date(s) or date(s) exposed.
  - c. This report will include all Sendera or eligible mares owned by the owner of the stallion, as well as all Sendera or eligible mares owned by other parties.
4. The “Release of Breeding” column – Placing your initials in this column allows the owner of the resulting foal to register it without the stallion owner’s signature on the application. This is an easy way for the stallion owner and mare owner to register the foal without further signatures after the transaction.
5. When presented with an outside mare to breed, demand to see the registration certificate of each mare to be exposed. This will assist you in the creation of this report.
6. Verify the last recorded owner or recorded lessee of the mare is the person who contracts the breeding to this stallion.
7. Give exact date(s) exposed. If more than one service is given to the mare, record each service date.
8. If pasture bred, give the date the mare was turned into the pasture and the date she was removed from the pasture.
9. Keep a copy of this report for your files and future use.

**NOTE:** All registered Sendera, Approved Cross or eligible mares bred or exposed means **ALL** mares exposed. Including those that might not be in foal, those a Veterinarian confirmed are not in foal, the mares you may not be intending to register the foal, etc. **ALL SENDERA, APPROVED CROSS OR ELIGIBLE MARES BRED OR EXPOSED TO THE STALLION MUST BE LISTED ON THE STALLION BREEDING REPORT.**
