### I. REQUEST FOR THE FOLLOWING UPDATE OF REGISTRATION:

1. Death Report – This is to notify the Registry of the death of a registered horse or unregistered foal. The original Registration Certificate may be returned, but is not required. The death will be noted in the registered horse's file; if the foal was not yet registered, the progeny information will be logged for the dam and sire.
2. Sold as Unregistered or Unregisterable – This is to notify the registry of a horse sold without the Registration Certificate (if registered) or sold before or without registration.
- If the Certificate of a registered horse has been placed on hold - the recorded owner may contact the registry to request the Certificate be renewed, reinstated or reissued to the new owner with a signed transfer using FORM TF.1207, at the current fee listed.
  - If not previously registered, please include the foaling date, sex of foal, complete dam and sire information and the signature of the owner of the dam. The sale will be noted in the registered horse's file and will be placed on hold; an unregistered horse will have the progeny information logged for the dam and sire.
  - In the case of a horse sold as unregistered - contact the registrar for more details specific to your case.
3. Notice of Sale without Completed Transfer – This is to notify the registry of a sale in which the transfer was not completed at the time of sale (example: auction, third party sale) and cannot be completed at this time. The date of sale will be noted in the horse's file and placed on hold; the owner on record can contact the registry to request the Certificate be renewed, reinstated or reissued to the new owner with a signed transfer. Contact the registrar for more details specific to your case.
4. Sterilization Report – The gelding and spaying of all animals must be recorded. A replacement Certificate can be requested using FORM CR.1511, at the current fee listed.
